| WHEREAS New Wave Pools LLC is a company engaged in the business of servicing and maintaining residential and commercial swimming pools and spas and is willing to provide such services to (customer name) as per the terms herein.  |  |  |

| 1.) Maintenance Services - Regular services included in this contract price: Maintaining the water cleanliness, clarity, and chemistry of the swimming pool and/or spa (daily, weekly, or bi-weekly)   |  |  |

| <ul> <li>Visually inspect swimming pool for water clarity</li> <li>Visually inspect swimming pool equipment</li> <li>Backwash the filter when necessary</li> <li>Check skimmer baskets, pump baskets, and water temperature of the swimming pool</li> <li>Test water chemistry of swimming pool</li> <li>Adjust water chemistry as needed</li> <li>Broom and brush all sides and bottom of swimming pool. | Additional services that are available for an additional fee, or other charges:  |  |  |
| <b>Repairs</b> – Any repairs that are necessary are not included in this contract. Repairs are completed at a rate of \$80.00 per hour per technician. The labor rate for repairs does not include the cost of any replacement parts necessary to complete the repair. The service call charge and/or return trip charge will be waived for residential maintenance customers, who possess valid contracts, as long as, the necessary repairs are completed during a scheduled maintenance date.   |  |  |
| <b>Spa Maintenance</b> – The maintenance of a spa/hot tub can be purchased as a standalone service, or as a service added to the swimming pool maintenance. The rate for providing spa/hot tub maintenance as a stand-alone package is \$30.00 per week. The rate for adding the spa/hot tub maintenance to the swimming pool maintenance is an additional \$20.00 per week.   |  |  |
| Chemical Delivery – New Wave Pools LLC will delivery requested chemicals to the swimming pool property during scheduled maintenance dates. There is no additional cost for this service. Chemicals will be billed at retail cost.  |  |  |
| 2.) Excluded Services - Unless authorized in writing by the customer, New Wave Pools LLC shall not be required to make any of the following:   |  |  |
| <ul><li>a.) Other safety tests or installations, whether or not recommended or directed by governmental authorities or by insurance companies.</li><li>b.) Any replacements with parts of a different design.</li><li>c.) Repairs or renewals caused by negligence or misuse of the equipment or any other factor except ordinary wear and tear.</li><li>d.) | The repairs of any equipment are not included in the residential maintenance contract. However, residential maintenance customers, who possess a valid maintenance contract, will have the service call fee, or return trip fee waived when repairs are completed on a scheduled maintenance date. The labor rate for repairs is \$80.00 per hour per technician. The service call fee is \$80.00, and the return trip fee is \$40.00 when applicable. The hourly labor rate does not include the cost of parts to complete the necessary repairs.   |  |  |
| <b>3.) Trained Technicians</b> – New Wave Pools LLC employees are NSPI and APSP certified technicians. The trained technicians directly employed and supervised by New Wave Pools LLC will perform all services required by the terms of this contract. New Wave Pools LLC agrees that each of its employees are properly qualified and will use reasonable care in the performance of their duties.   |  |  |
| <b>4.) Working Hours</b> – The services required of New Wave Pools LLC under this contract, including emergency service, shall be performed during regular working hours of its regular working days, consisting of start time 7:00 a.m. to end time 7:00 p.m. Monday through Friday. Dates for service vary by service location. New Wave Pools LLC strives to provide superior customer service and understands that exceptions may need to be made to starting times, ending times, holidays, or scheduling based on location.
